If you are eligible for a low-income rate or fuel assistance, those benefits will continue in Valley Green Energy. You will continue to receive your discount with no change.

If you have a tax-exempt account, you should know that taxes will be billed as part of the Valley Green Energy power supply charge, and you are responsible for identifying and requesting an exemption from the collection of any tax. If you wish to retain your tax-exempt status in the program, you must provide appropriate tax-exemption documentation to [SUPPLIER NAME].
