## A NOTIFICATION FROM THE TOWN OF CHELMSFORD ABOUT A CHANGE IN YOUR ELECTRICITY SUPPLY PRICE

Dear Chelmsford Electricity Customer,

### **This notice contains important information about a price change on your National Grid electric bill.**

Your electricity account is enrolled in Chelmsford Choice, the Town's electricity program. The program gives you a Chelmsford price for the Supply Services portion of your National Grid electric bill. You are enrolled in the Basic option, which means you receive the lowest price available through the program.

Chelmsford currently has a contract with Constellation to supply electricity to Chelmsford Choice participants. That contract will expire in November of this year, and a new, 24-month contract with Dynegy will go into effect.

### **The new contract will bring new prices.**

The Constellation contract was signed in 2020 and has kept our prices low. However, electricity supply prices have risen significantly since then because of volatility in global energy markets. Chelmsford Choice prices will move to market levels when the Dynegy contract takes effect.

#### ▶ **Your new Chelmsford Choice price: 14.843 ¢/kWh**

The new price is fixed for 24 months, from November 2023 - November 2025.

Your new electricity supply price will be higher than your current price, but it will be **lower** than National Grid's winter residential Basic Service price of 18.213 ¢/kWh, which will take effect on November 1.

*Please note that because National Grid's prices change and future prices are not known, future savings compared with National Grid's prices cannot be guaranteed.*

### **Your choices:**

- ▶ **Take no action and remain in Chelmsford Choice.** If you wish to continue participating in Chelmsford Choice in the Basic option, no action is required. Your enrollment will renew automatically at 14.843 ¢/kWh in November 2023. You will first see the new price on your National Grid electric bill in December 2023.
- ▶ **Change to another plan in the program.** You may choose to opt up to the Greener option and receive an additional 40% of your electricity from renewable sources for 16.415 ¢/kWh, or opt up to the Greenest option and receive 100% of your electricity from renewable sources and none from fossil fuels for 17.849 ¢/kWh.
- ▶ **Leave the program with no penalty or fee.** You are free to either return to National Grid's Basic Service pricing or sign your own contract with an electricity supplier.

## Your options in Chelmsford Choice

The Commonwealth of Massachusetts requires that all electricity supply products include a minimum of 59% from renewable or clean energy resources in 2023, 62% in 2024, and 63% in 2025. The Basic option meets this requirement. The Greener and Greenest options exceed it.

\* Prices include a \$0.001/kWh administrative fee. Program prices could increase as a result of a change in law that results in a direct, material increase in costs during the term of the electricity supply agreement.

\*\* The Greenest option is a 100% MA Class I REC offering, which means it includes the minimum amount of MA Class I RECs required by law each year plus the additional amount needed to reach 100%. Chelmsford's electricity supplier must also purchase other renewable energy from other clean or renewable sources required by state law to meet state requirements. As a result, the total of the renewable content for the Greenest option exceeds 100%. (For example, for 2023, 78% MA Class I RECs + 22% MA Class I RECs + 37% other clean or renewable sources required by law.)
