A message from the Town of Natick about 2024-2025 electricity prices

Natick Electricity Aggregation Program prices are coming down.

You are currently enrolled in the Town of Natick's Electricity Aggregation, our community's group electricity buying program. The program is provided as a service to the community, and Natick electricity customers are automatically enrolled. Through the program, you receive a Natick price for the supply portion of your Eversource electric bill instead of Eversource's Basic Service price, though the program cannot guarantee savings compared with Eversource's prices. You are enrolled at the **100% Green level**.

Natick currently has a contract with First Point Power to supply electricity to program participants. That contract will expire in December of this year, and a new, 24-month contract with First Point Power will go into effect. **The new contract will bring new, lower prices.**

▶ **Your electricity supply price is decreasing by more than 6 ¢/kWh.**

Your current electricity supply price is 23.624 ¢/kWh.

Your new, lower price for electricity supply will be 17.474 ¢/kWh.

The new price will be in effect for 24 months until December 2025. You will continue to receive 100% of your electricity from new renewable resources in the New England region.

You can compare your new price with Eversource's current Basic Service prices on the other side. Eversource's prices will next change on January 1, and their 2024 prices are not yet known. ***Because Eversource's future prices are not known, future savings compared with Eversource cannot be guaranteed.***

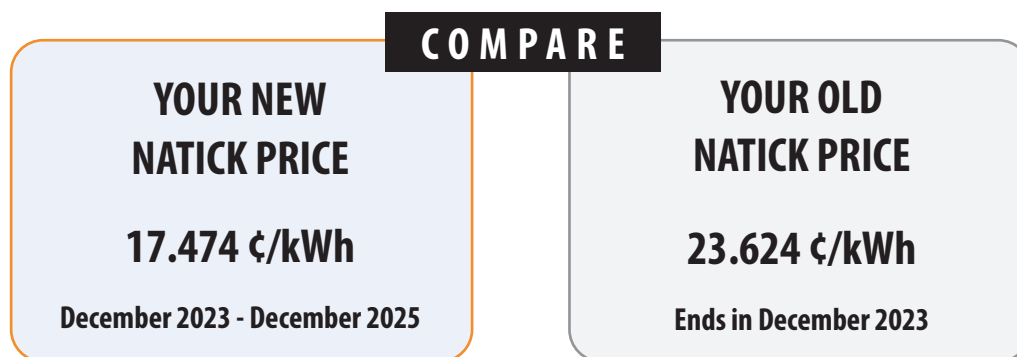
▶ **Next steps**

Participating in the Natick Electricity Aggregation Program is a choice. You can leave any time with no fee or penalty. The Town does not make any money on this program.

If you want to continue participating: no action is required. If you do nothing, the new price will go into effect in December 2023, and you will first see it on your January 2024 Eversource electric bill.

If you want to leave the program: You can enroll with Eversource's Basic Service and receive their upcoming winter Basic Service price or sign your own contract with an electricity supplier.

▶ Natick Electricity Aggregation Program options & pricing

The Natick Electricity Aggregation Program offers three options, each with a different price and environmental impact. These options are displayed in the chart below. You are currently enrolled in Natick 100% Green. If you would like to change to a different option, visit NatickElectricityAggregation.com, call 1-844-483-5004, or email electricity@natickma.org.

The Commonwealth of Massachusetts requires that all electricity supply products include a minimum of 59% from renewable energy resources in 2023, 62% in 2024, and 63% in 2025. Natick Basic/Brown meets the minimum requirement. Natick Standard Green and Natick 100% Green exceed this requirement.

* Prices include a \$0.001/kWh administrative fee. Program prices could increase as a result of a change in law that results in a direct, material increase in costs during the term of the electricity supply agreement.
 ** Natick 100% Green includes the minimum amount of MA Class I RECs required by law each year plus the additional amount needed to reach 100%. Natick's electricity supplier must also purchase other renewable energy to meet state requirements. As a result, the total renewable content for Natick 100% Green exceeds 100%.
 *** Exit terms for Eversource's Basic Service: No exit charge. However, large C&I (rates G-3, T-2, and WR) and street lighting customers on the fixed-price Basic Service option may receive a billing adjustment, which may be either a credit or a charge.
