MUNICIPAL ELECTRICITY AGGREGATION PROGRAM PRICE CHANGE NOTIFICATION LETTER

November 8, 2023

Dear Acton Power Choice Participant,

Your electricity account is currently enrolled in Acton Power Choice, the Town's electricity program, in the **Acton Power Choice Green** option. Through the program, you receive 100% of your electricity from new renewable resources in the New England region (MA Class I RECs). Acton currently has a contract with NextEra Energy Services to supply electricity to program participants. That contract will come to an end in December, and a new, 36-month contract with First Point Power will go into effect.

The new contract will bring two changes:

- 1. Lower prices** - Your new Acton Power Choice price will be lower than your current price, though savings compared with Eversource's Basic Service prices cannot be guaranteed.
- 2. Three years of price stability** - Your new Acton Power Choice price is fixed for 36 months.

However, you will continue to receive 100% renewable electricity with no change.

▶ **Your new price for Acton Power Choice Green: 17.039 ¢/kWh**

This price will be in effect for 36 months, from December 2023 until December 2026.

Your new price is lower than your current Acton Power Choice Green price of 20.750 ¢/kWh. Compare this price with Eversource's current Basic Service prices on the other side. Eversource's Basic Service prices will change on January 1, and their 2024 prices are not yet known. *Because Eversource's future prices are not known, future savings compared with Eversource cannot be guaranteed.*

Your options:

- ▶ **Take no action and remain in Acton Power Choice.** If you wish to continue participating in Acton Power Choice at the Green level, no action is required. Your enrollment will renew automatically at the new price in December 2023. You will first see the new price on your January 2024 Eversource electric bill.
- ▶ **Change to another option in the program.** You may opt down to Acton Power Choice Standard and receive an additional 45% of your electricity from new renewable resources in the New England region (MA Class I RECs), in addition to the minimum amount required by law, or opt down to Acton Power Choice Basic and receive just the minimum renewable energy required by law.
- ▶ **Leave the program with no penalty or fee.** You are free to either return to Eversource's Basic Service pricing or sign your own contract with an electricity supplier.





Your options in Acton Power Choice

The Commonwealth of Massachusetts requires that all electricity supply products include a minimum of 59% from renewable or clean energy resources in 2023, 62% in 2024, 63% in 2025, and 69% in 2026. Acton Power Choice Basic meets the minimum requirement. Acton Power Choice Standard and Acton Power Choice Green **exceed it**.

However, large C&I (rates G-3, T-2, and WR) and street lighting customers on the fixed-price Basic Service option may receive a billing adjustment, which may be either a credit or a charge.

* Acton Power Choice prices include a \$0.001/kWh administrative fee. Program prices could increase as a result of a change in law that results in a direct, material increase in costs during the term of the electricity supply agreement.

** When Acton voluntarily purchases extra renewable electricity, the Town prioritizes the purchase of renewable energy from new, emissions-free sources in the New England region (MA Class I RECs). To meet state requirements, Acton's electricity supplier must also purchase electricity from other sources, some that are renewable but not clean and some that are clean but not renewable. As a result, the total of the renewable electricity purchased for both Acton Power Choice Standard and Acton Power Choice Green participants exceeds 100% of the electricity they use.

Tax-exempt account holders take note: You must provide appropriate tax-exemption documentation to First Point Power in order to maintain tax-exempt status. Visit ActonPowerChoice.com for information on where to submit your documentation.
