A NOTIFICATION FROM THE CITY OF GREENFIELD ABOUT A CHANGE IN YOUR ELECTRICITY SUPPLY PRICE



December 1, 2023

Dear Greenfield Electricity Customer,

This notice contains important information about a price change on your Eversource electric bill.

Your electricity account is enrolled in the City's electricity program, Greenfield Light & Power, in the **Standard** option. Participating in Greenfield Light & Power gives you a Greenfield price for the Supply portion of your Eversource electric bill, which is the part of the bill where you pay for the electricity you use. In addition, through the program you are receiving 100% of your electricity from renewable sources.

The electricity supply contract that guarantees our community's electricity prices will end in January, and a new, 24-month contract will go into effect. **The new contract will bring two changes:**

- 1. **New prices** The current contract was signed in 2020 and has kept our prices low. However, electricity supply prices have risen significantly because of volatility in global energy markets. Greenfield Light & Power prices will move to market levels when the new contract takes effect.
 - Your new price for the Supply portion of your Eversource electric bill: 13.498 ¢/kWh
 The new price is fixed for 24 months, from January 2024 January 2026.

Your new price will be higher than your current price, but it is **lower** than Eversource's winter 2024 residential Basic Service price of 15.845 ¢/kWh, which will go into effect on January 1. *Please note that because Eversource's prices change and their future prices are not known, future savings compared with Eversource's prices cannot be guaranteed.*

2. More support for renewable energy in New England - Through the program, you already receive 100% of your electricity from a variety of renewable sources. As part of that, you receive the minimum from new renewable resources in the New England region required by law, plus an additional 5%. With the new contract, that additional amount will increase to 10%.

Your options:

- ► Take no action and remain in Greenfield Light & Power. If you wish to continue participating in Greenfield Light & Power in the Standard option, no action is required. Your enrollment will renew automatically at the new price in January 2024. You will first see the new price on your Eversource electric bill in February 2024.
- ► Change to another option in the program. You may opt up to the Local Green option for 100% renewable electricity, *all* from new renewable resources in the New England region, or opt down to the **Budget** option to receive 100% renewable electricity at the lowest price available in the program.
- Leave the program with no penalty or fee. You are free to either return to Eversource's Basic Service pricing or sign your own contract with an electricity supplier.

Your options in Greenfield Light & Power

All Greenfield Light & Power options provide 100% of your electricity from renewable sources. The options differ in the amount of electricity purchased from new renewable resources in the New England region (MA Class I RECs). Buying from new renewable resources in our region helps to build demand for more local renewable energy and supports the jobs that go with it.

The chart below can help you decide whether to remain enrolled in your current option, change to another option in the program, or opt out and return to Eversource's Basic Service. ^{*} Prices include a \$0.001/kWh administrative fee. Program prices could increase as a result of a change in law that results in a direct, material increase in costs during the term of the electricity supply agreement.

^{**} The Local Green option is a 100% MA Class I REC offering, which means it includes the minimum amount of MA Class I RECs required by law each year plus the additional amount needed to reach 100%. Greenfield's electricity supplier must also purchase other renewable energy to meet state requirements. As a result, the total of the renewable content for the Local Green option exceeds 100%. The Commonwealth of Massachusetts requires that all electricity supply products include a minimum from renewable or clean energy resources. All Greenfield Light & Power options exceed the minimum requirement.
