# A NOTIFICATION FROM THE TOWN OF LINCOLN ABOUT A CHANGE IN YOUR ELECTRICITY SUPPLY PRICE

December 8, 2023

Dear Lincoln Green Energy Choice Participant,



#### This notice contains important information about a price change on your Eversource electric bill.

Your electricity account is currently enrolled in Lincoln Green Energy Choice, the Town's electricity program, in the **Lincoln Basic** option. This is the least-expensive option in the program, and with it, you receive an additional 2% of your electricity from renewable sources. Beginning in January, a new electricity supply contract with First Point Power will go into effect.

#### The new contract will bring two changes:

- 1. A lower price Your new electricity Supply price will be 14.631 ¢/kWh.
  - Your new price is more than 6 cents/kWh lower than your current price of 21.206 ¢/kWh and also lower than Eversource's upcoming Basic Service price of 17.251 ¢/kWh, which will take effect on January 1. Because Eversource's future prices are not known, future savings compared with Eversource cannot be guaranteed.
- **2. Two years of price stability -** Your new electricity Supply price is fixed for 24 months and will not change from January 2024 January 2026.

# **Your options:**

- Take no action and remain in Lincoln Green Energy Choice. If you wish to continue participating in Lincoln Green Energy Choice at the Lincoln Basic level, no action is required. Your enrollment will renew automatically at the new, lower price in January 2024. You will first see the new price on your February 2024 Eversource electric bill.
- **Change to another option in the program.** You may choose to up to Lincoln Standard Green to receive an additional 38% to 44% of your electricity from renewable sources, or opt up to Lincoln 100% Green and receive 100% of your electricity from renewable sources.
- **Leave the program with no penalty or fee.** You are free to either return to Eversource's Basic Service pricing or sign your own contract with an electricity supplier.

The Commonwealth of Massachusetts requires that all electricity supply products include a minimum of 62% from renewable energy resources in 2024, 63% in 2025, and 69% in 2026. All Lincoln Green Energy Choice options exceed this requirement.

<sup>\*\*</sup> The renewable energy added by the Town of Lincoln in the three program options is from new resources in the New England region (MA Class I RECs), which are renewable energy projects built in 1998 or later and which are primarily wind and solar energy projects but can be other types of technologies. Lincoln's contract specifically excludes facilities that burn biomass.

<sup>\*\*\*</sup> These other resources include waste-to-energy, nuclear, and large hydro projects, among others.
