# A NOTIFICATION FROM THE TOWN OF SHARON ABOUT A CHANGE IN YOUR ELECTRICITY SUPPLY PRICE

Dear Sharon Electricity Customer,

## This notice contains important information about a price change on your Eversource electric bill.

Your electricity account is enrolled in Sharon Power Choice, the Town's electricity program. The program gives you a Sharon price for the Supply portion of your Eversource electric bill. You are enrolled in the **Sharon Power Choice Green option**, which means 100% of your electricity comes from new renewable resources in the New England region.

In January, Sharon's current electricity supply contract with Constellation will end, and a new, 36-month contract with Direct Energy Services, LLC, ("Direct Energy") will go into effect. **The new contract will bring new prices.** 

The current electricity supply contract was signed in 2020 and has kept our prices low. However, electricity supply prices have risen since then because of volatility in global energy markets. Sharon Power Choice prices will move to market levels when the Direct Energy contract takes effect.

## Your new price for Sharon Power Choice Green: 15.49 ¢/kWh

The new price is fixed for 36 months, from January 2024 - January 2027.

Your new electricity supply price will be higher than your current price, but it is lower than Eversource's upcoming residential Basic Service price of 17.251 ¢/kWh, which will be in effect from January 1 - July 31, 2024. Please note that because Eversource's prices change and future prices are not known, savings compared with Eversource's prices cannot be guaranteed beyond that date.

## Your options:

- **Take no action and remain in Sharon Power Choice.** If you wish to continue participating in Sharon Power Choice in the Sharon Power Choice Green option, no action is required. Your enrollment will renew automatically at the new price in January 2024. You will first see the new price on your February 2024 Eversource electric bill.
- Change to another option in the program. You may choose to opt down to the Sharon Power Choice Standard option and receive an additional 20% of your electricity from new renewable resources in the New England region (MA Class I RECs), or opt down to the Sharon Power Choice Basic option and receive just the minimum amount of renewable energy required by law.
- Leave the program with no penalty or fee. You are free to either return to Eversource's Basic Service pricing or sign your own contract with an electricity supplier.

## Your options in Sharon Power Choice

The Commonwealth of Massachusetts requires that all electricity supply products include a minimum of 62% from renewable energy resources in 2024, 63% in 2025, and 69% in 2026. Sharon Power Choice Basic meets this requirement. Sharon Power Choice Standard and Sharon Power Choice Green exceed it.

\* Prices include a \$0.001/kWh administrative fee and a \$0.001/kWh operational fee to support Town energy staff. Program prices could increase as a result of a change in law that results in a direct, material increase in costs during the term of the electricity supply agreement.

\*\* Sharon Power Choice Green is a 100% MA Class I REC offering, which means it includes the minimum amount of MA Class I RECs required by law each year (24% in 2024, 27% in 2025, 30% in 2026) plus the additional amount needed to reach 100% (76% in 2024, 73% in 2025, 70% in 2026). Sharon's electricity supplier must also purchase other renewable energy to meet state requirements. As a result, the total of the renewable content for Sharon Power Choice Green exceeds 100%.

**Tax-exempt account holders, please take note:** You must provide appropriate tax-exemption documentation to Direct Energy to maintain tax-exempt status. Visit **MassPowerChoice.com/Sharon/TaxExempt** for details.
