Town Electricity Aggregation Program Notification Letter



March 20, 2024

Dear Wayland Electricity Customer,

This letter contains important information about **Wayland Electricity Choice**, a new Town electricity program that will help our community take a big step toward achieving its sustainability goals.

The program is an electricity aggregation, which is a kind of group electricity buying program for cities and towns with no hidden fees or penalties. Participating in Wayland Electricity Choice changes the Supply price on your Eversource bill, which is the part of the bill where you are charged for the electricity you use.

Through Wayland Electricity Choice, you have three new choices for your electricity supply, including two that provide more of your electricity from renewable sources. Additional benefits include stable, long-term prices that do not change seasonally, consumer protections, and the potential for savings compared with Eversource's prices, though savings cannot be guaranteed.

Your choices

Program options with *Green* in the name provide more electricity from renewable sources than the minimum required by law.

- 1 Automatic enrollment:** If you take no action, you will be **AUTOMATICALLY** enrolled in **Wayland Standard Green** for **13.224 ¢/kWh**. You will receive 20% of your electricity from new renewable resources in the New England region (MA Class I RECs), which is greater than the minimum amount required by state law. Please note: The automatic enrollment model is in accordance with state law for programs like Wayland Electricity Choice, but you are not required to participate.
- 2 Choose the Wayland 100% Green option:** Receive all of your electricity from new renewable resources in the New England region (MA Class I RECs) for 15.384 ¢/kWh.
- 3 Choose the Wayland Economy option:** Enjoy price stability but receive no additional electricity from renewable sources beyond the minimum required by state law for 12.424 ¢/kWh.
- 4 Choose not to participate:** If you choose not to participate in Wayland Electricity Choice, you will remain with Eversource's Basic Service for your electricity supply. Eversource offers no additional electricity from renewable sources beyond the minimum required by state law. Please see the back for Eversource's current prices.

If you do not wish to participate in Wayland Electricity Choice, you must opt out. To opt out before being automatically enrolled, you must do one of the following before April 22, 2024:

Visit WaylandElectricityChoice.com and opt out online, call 1-844-202-6400 and opt out by phone, or sign and mail the enclosed reply card (must be postmarked by April 22, 2024). You are also free to try the program and opt out at any time in the future. There is no penalty or fee to opt out.

All Wayland Electricity Choice prices are fixed until **May 2026**. In comparison, Eversource's Basic Service prices change every 6 months for residential and small business customers and every 3 months for large business customers.

Wayland Electricity Choice does offer the potential for savings compared with Eversource's Basic Service prices, but because Eversource's future prices are not known, savings compared with Eversource cannot be guaranteed.

Changes to your electric bill

Wayland Electricity Choice will not replace Eversource as your electric utility, and you will not notice any change in your electricity service. Eversource will continue to deliver your electricity and send your electric bill, and you will continue to call Eversource if your power goes out.

You will see just two changes on your Eversource electric bill:

- Wayland has signed a contract with First Point Power to supply electricity to participants in Wayland Electricity Choice, so WaylandElectricityChoice-FirstPoint will be listed on your bill as your electricity supplier.
- The Supply charge on your bill will be calculated using a Wayland Electricity Choice price instead of Eversource's Basic Service price. Eversource's Delivery charges will not be impacted.

* Program prices include a \$0.001/kWh administrative fee. Program prices could increase as a result of a change in law that results in a direct, material increase in costs during the term of the electricity supply agreement. For those customers subject to electricity taxes, taxes will be billed as part of the Wayland Electricity Choice power supply charge.

** Wayland 100% Green includes the minimum amount of MA Class I RECs required by law each year plus the additional amount needed to reach 100%. Wayland's electricity supplier must also purchase other renewable energy to meet state requirements. As a result, the total renewable content for Wayland 100% Green exceeds 100%.

Additional information

At the end of the price period, the Town intends to enter into a new electricity supply contract. At that time, the price and renewable energy content may change. If you are still enrolled in Wayland Electricity Choice at that time, you will receive a notice informing you of any changes.

If you are eligible for a low-income rate or fuel assistance, those benefits will continue in Wayland Electricity Choice. You will continue to receive your discount with no change.

If you have a tax-exempt account, you should know that taxes will be billed as part of the Wayland Electricity Choice power supply charge, and you are responsible for identifying and requesting an exemption from the collection of any tax. If you wish to retain your tax-exempt status in the program, you must provide appropriate tax-exemption documentation to First Point Power. Visit WaylandElectricityChoice.com for information on how to submit your documentation.

If you have received this letter and also you have signed a contract with an electricity supplier, you may have signed your contract after this mailing list was created. To continue receiving electricity from the supplier you chose and to prevent any early termination fees from that supplier, you should opt out of Wayland Electricity Choice.

If you have solar panels on your property or participate in a community solar program, there will be no change. You will continue to receive solar credits and/or solar incentive payments, and there will be no change to the way they are calculated.

Eversource will remain responsible for billing you, and your Eversource electric bill is the only electric bill you will receive as a participant in Wayland Electricity Choice. If you have set up electronic billing with Eversource, there will be no change.

If you have Eversource's budget billing, that will change. For participants in Wayland Electricity Choice, budget billing will apply only to Eversource's Delivery charges and will no longer apply to Eversource's Supply charge. If you wish to retain budget billing for the Supply charge portion of your bill, you should opt out of Wayland Electricity Choice and remain on Eversource's Basic Service.

Electricity Supply Product Summary for WAYLAND STANDARD GREEN *from Wayland Electricity Choice*

You will receive an electric supply product through Wayland Electricity Choice.

Your electric utility, Eversource, will continue to deliver the electricity you use to your home or business.

Price	13.224 cents per kWh. This does not include the price that your electric utility will charge you for the delivery component of your electric service.
Term	The price is fixed from your enrollment through May 2026.
Early Cancellation Fee	There is no cancellation fee. You may leave Wayland Electricity Choice at any time with no fee or penalty.
Automatic Renewal	You will be automatically enrolled in Wayland Standard Green at a new price at the end of the contract term unless you inform the Town otherwise. The new price may be higher or lower than the existing price. The Town will contact you no later than 30 days before each automatic renewal to notify you of your supply options.
Renewable Energy Content	The Commonwealth of Massachusetts requires that all electric supply products include a minimum of 62% renewable energy resources in 2024, 63% in 2025, and 69% in 2026. This product exceeds the minimum requirement and includes an additional 20% renewable electricity from MA Class I RECs. The renewable energy content may change at the end of the contract term. If it does, the Town will contact you no later than 30 days in advance of that change.
Rescission Period	If you have received this form as part of an automatic enrollment notice, you have until the deadline indicated on the notice to opt out and avoid automatic enrollment in Wayland Electricity Choice. You may leave Wayland Electricity Choice at any time after being enrolled with no fee or penalty.
Competitive Supplier Information	Wayland Electricity Choice is a program of the Town of Wayland. The program is served by First Point Power, DPU license number: CS-082, 1-888-875-1711, www.firstpointpower.com. First Point Power is only responsible for the electric generation portion of your bill.
Electric Utility Information	Eversource will continue to deliver the electricity that you use in your home and is responsible for the delivery charges that appear on your monthly bill. If you have questions about the delivery portion of your bill, contact Eversource at 800-592-2000, or by visiting its website at Eversource.com.
