Town Electricity Aggregation Program Notice



April 2, 2024

Dear Sherborn Electricity Customer,

This letter contains important information about **Sherborn Power Choice**, a new Town electricity program that will help our community to take a big step toward achieving its sustainability goals. Through Sherborn Power Choice, our community will receive an additional 50% of our electricity from renewable sources. The program also provides choices for you to receive more or less renewable electricity.

If you received this letter and you do nothing, you will be automatically enrolled in Sherborn Power Choice in June 2024.

If you don't want to participate, you don't have to. **To prevent your account from being automatically enrolled, you must opt out by May 6, 2024.** You are also free to try the program and opt out later at any time with no fee or penalty.

Sherborn Power Choice offers three new choices for your electricity supply:

1 If you choose to participate, you will be automatically enrolled in **Sherborn Standard**. Your electricity supply price will be **14.046 ¢/kWh**. You will receive 50% renewable electricity from new resources in the New England region (MA Class I RECs), in addition to the minimum renewable energy required by state law.

Or you may request one of the other two choices in the program instead:

2 **Sherborn Select** is an option that provides 100% renewable electricity from new renewable resources in the New England region (MA Class I RECs) for 15.086 ¢/kWh.

3 **Sherborn Basic** is an option that provides only the minimum amount of renewable electricity required by state law for 12.046 ¢/kWh.

Sherborn Power Choice will not replace Eversource as your electric utility, and you will

not notice any change in your electricity service. Eversource will continue to deliver your electricity and send your electric bill, and you will continue to call Eversource if your power goes out. You will see just two changes on your electric bill:

1. "Sherborn Power Choice - Gridwealth" will be listed on your bill as your electricity supplier. Sherborn has signed a contract with Gridwealth Electric to supply electricity to the community until June 2024.
2. Eversource will calculate the Supply charge on your bill using a Sherborn Power Choice price instead of the Basic Service price. Eversource's Delivery charges will not be impacted.

Sherborn Power Choice prices will not change until **June 2026**. In comparison, Eversource's Basic Service prices change every 6 months for residential and small business customers and every 3 months for large business customers. **(Please note: Because future Eversource prices are not known, savings compared with Eversource cannot be guaranteed.)**

* Program prices include a \$0.001/kWh administrative fee. Prices also include an operational fee of \$0.001/kWh, which will generate a total of approximately \$20,000 per year to support the cost of town staff who work on the Program. Program prices could increase as a result of a change in law that results in a direct, material increase in costs during the term of the electric supply agreement. For those customers subject to electricity taxes, taxes will be billed as part of the Sherborn Power Choice power supply charge.

** The Sherborn Standard and Sherborn Select options include the minimum amount of MA Class I RECs required by law each year plus additional amounts added by Sherborn. Sherborn's electricity supplier must also purchase electricity from other clean or renewable sources to meet state requirements. As a result, the total renewable content for Sherborn Standard and Sherborn Select exceeds 100%.

Additional information

If you are eligible for a low-income rate or fuel assistance, those benefits will continue in Sherborn Power Choice.

If you have a tax-exempt account, you are responsible for identifying and requesting an exemption from the collection of any tax by providing appropriate tax-exemption documentation to Gridwealth Electric. Visit SherbornPowerChoice.com to learn more.

If you have solar panels on your roof or you participate in a community solar program, you will continue to receive solar credits and/or solar incentive payments, and participating in Sherborn Power Choice will not change how they are calculated.

If you have received this letter and also you have signed a contract with an electricity supplier, you may have signed your contract after this mailing list was created. To continue receiving electricity from the supplier you chose and to prevent any early termination fees from that supplier, you must opt out of Sherborn Power Choice.

Electricity Supply Product Summary for SHERBORN STANDARD from Sherborn Power Choice

You will receive an electric supply product through Sherborn Power Choice.
Your electric utility, Eversource, will continue to deliver the electricity you use to your home or business.

Price	14.046 cents per kWh. This does not include the price that your electric utility will charge you for the delivery component of your electric service.
Term	The price is fixed from your enrollment through June 2026.
Early Cancellation Fee	There is no cancellation fee. You may leave Sherborn Power Choice at any time with no fee or penalty.
Automatic Renewal	You will be automatically enrolled in Sherborn Standard at a new price at the end of the contract term unless you inform the Town otherwise. The new price may be higher or lower than the existing price. The Town will contact you no later than 30 days before each automatic renewal to notify you of your supply options.
Renewable Energy Content	The Commonwealth of Massachusetts requires that all electric supply products include a minimum of 62% renewable energy resources in 2024, 63% in 2025, and 69% in 2026. This product exceeds the minimum requirement and includes an additional 50% renewable electricity from new resources in the New England region (MA Class I RECs). The renewable energy content may change at the end of the contract term. If it does, the Town will contact you no later than 30 days in advance of that change.
Rescission Period	If you have received this form as part of an automatic enrollment notice, you have until the deadline indicated on the notice to opt out and avoid automatic enrollment in Sherborn Power Choice. You may leave Sherborn Power Choice at any time after being enrolled with no fee or penalty.
Competitive Supplier Information	Sherborn Power Choice is a program of the Town of Sherborn. The program is served by Gridwealth Electric, DPU license number: CS-189, 1-877-700-6165, GridWealth.com. Gridwealth Electric is only responsible for the electric generation portion of your bill.
Electric Utility Information	Eversource will continue to deliver the electricity that you use in your home and is responsible for the delivery charges that appear on your monthly bill. If you have questions about the delivery portion of your bill, contact Eversource at 800-592-2000, or visit its website at Eversource.com.
