Regional electricity program notification of automatic enrollment

You are receiving this notice because your electricity account is eligible for **AUTOMATIC ENROLLMENT** in Valley Green Energy. Your electricity account number is shown on the enclosed reply card.

Valley Green Energy is a new group electricity buying program that was created by, and for, the communities of Pelham, Amherst, and Northampton. The program provides long-term, stable electricity supply prices, more electricity from renewable sources, and consumer protections.

Participating in Valley Green Energy means:

- The supply price on your Eversource electric bill will change to **13.994 ¢/kWh**, which is **lower** than Eversource’s current residential Basic Service price and fixed until November 2026.
- An additional **10%** of your electricity will automatically come from clean, renewable sources.
- You will remain an Eversource customer, and Eversource will continue to deliver your electricity and send your electric bill.

Eversource’s prices change and future prices are unknown, so future savings compared with Eversource cannot be guaranteed.

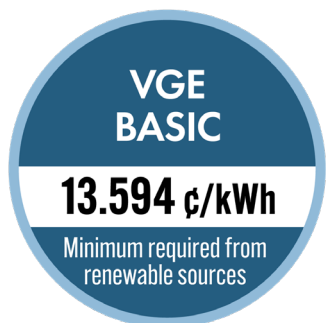

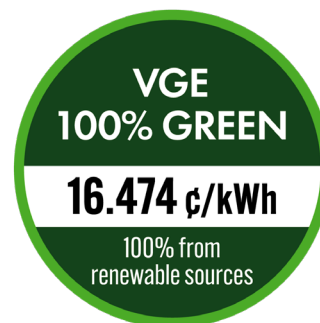
- ▶ **TAKE NO ACTION:** You will be automatically enrolled in the VGE Standard Green option with your November 2024 meter read, and you will receive an additional 10% of your electricity from clean, renewable sources.

- ▶ **OPT OUT:** Participation is not required. There is no penalty to opt out of Valley Green Energy, and you may do so at any time. To avoid automatic enrollment, submit your opt-out request by **October 2, 2024**. Or you may try the program and opt out at any time in the future.

* State law requires all electricity suppliers to purchase Renewable Energy Certificates (RECs) from other sources, including sources that are not new, are renewable but not clean, such as waste to energy, or are clean but not renewable, such as nuclear. This purchase must be made even if it means the total amount of RECs purchased from either clean or renewable sources exceeds 100% of the electricity used by Valley Green Energy participants.

Additional information:

Your electricity supplier will be First Point Power. On your bill, you will see "First Point-Valley Green Energy PLM," but your primary relationship for electricity remains with Eversource, and you will continue to call them if your power goes out. In addition, Eversource will continue to send your electric bill, and this is the only electric bill you will receive as a participant in Valley Green Energy.

If you are eligible for a low-income discount or fuel assistance, those benefits will continue in Valley Green Energy.

If you have solar panels on your property or you participate in a community solar program, you will continue to receive solar credits and/or solar incentive payments, and participating in Valley Green Energy will not change how they are calculated.

If you have a tax-exempt account, you are responsible for requesting an exemption from the collection of any tax by providing tax-exemption documentation to First Point Power. Visit ValleyGreenEnergy.org to learn more.

If you have received this notice and also you have signed a contract with an electricity supplier, you may have signed your contract after this mailing list was created. To continue receiving electricity from the supplier you chose and prevent any early termination fees from that supplier, **you must opt out of Valley Green Energy.**

The automatic enrollment model is in accordance with state law. Nearly 200 cities and towns in Massachusetts have similar programs, and all operate the same way. However, you are not required to participate. You may opt out at any time with no fee or penalty.

At the end of the contract with First Point Power, the Valley Green Energy communities intend to sign new long-term contracts. The electricity supplier and renewable energy content may change, and the price may be higher or lower than the current price. You will continue in the same program option at the new price unless you inform the program otherwise. Valley Green Energy will provide advance notice of any such changes, and you will be free to opt out or change your option before the changes take effect.

Your opt-out request must be made by, or the envelope must be postmarked by, **October 2, 2024**, to opt out of the program before being automatically enrolled. If you choose to participate, you may opt out at any time in the future with no fee or penalty.
