



An important message from the Town of Bellingham about a change in your electricity supply price

October 22, 2025

Your electricity account is enrolled in **Bellingham Power Choice**, our Town's group electricity buying program. Through the program, you receive a Bellingham Power Choice price for the electricity supply part of your Eversource electric bill.

Within the program, you are enrolled in the **Power Choice Green** option, which means you receive 100% of your electricity from renewable sources.

In December, the program's current electricity supply contract with Direct Energy will expire, and a new, 12-month contract with Gridwealth Electric will go into effect that fixes prices until December 2026. Under the new contract:

- You will receive a **lower price**. Your electricity supply price will change from 16.770 ¢/kWh to **15.774 ¢/kWh**.
- You will continue to receive **100% of your electricity** from renewable sources.
- Your new price will be fixed and stable until **December 2026**.

Your new electricity supply price:

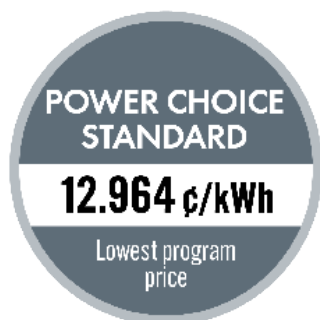

It's your decision. Make the choice that's right for you.

- ▶ **TAKE NO ACTION:** Your enrollment in Bellingham Power Choice Green will automatically renew at 15.774 ¢/kWh in December, and you will see the new, lower price on your January Eversource electric bill.
- ▶ **CHOOSE POWER CHOICE STANDARD:** Choose the Power Choice Standard option to receive the minimum from renewable sources required by state law for 12.964 ¢/kWh.
- ▶ **OPT OUT:** Participation is not required. There is no fee or penalty to opt out of Bellingham Power Choice, and you may do so at any time. If you opt out, you will be returned to Eversource's Basic Service price.

* State law requires all electricity suppliers to purchase Renewable Energy Certificates (RECs) from other sources, including sources that are not new, are renewable but not clean, such as waste to energy, or are clean but not renewable, such as nuclear.

Additional information:

- **Bellingham Power Choice has saved participants more than \$5 million** compared with utility Basic Service prices since the program's launch in 2017. However, because Eversource's prices change and future prices are not known, **future savings cannot be guaranteed.**
- **Your electricity supplier will change to Gridwealth Electric.** On your bill, you will see "Gridwealth-Bellingham Power Choice." As always, your primary relationship for electricity remains with Eversource, and you will continue to call them if your power goes out. In addition, Eversource will continue to send your electric bill, and this is the only electric bill you will receive as a participant in Bellingham Power Choice.
- **If your account is tax exempt,** you must submit your tax-exemption documentation to Gridwealth Electric. Tax-exemption documentation must be submitted each time the program's electricity supplier changes. For information on where to submit your tax-exemption documentation, visit BellinghamPowerChoice.com.
- **At the end of the new contract with Gridwealth Electric,** the Town intends to sign another long-term contract. The electricity supplier and renewable energy content may change, and the price may be higher or lower than the current price. You will continue in the same program option at the new price unless you inform the program otherwise. The Town will provide advance notice of any such changes, and you will be free to opt out or change your option before the changes take effect.
