Dear Beverly Community Member,

I am excited to announce the Beverly Community Electric program has secured a second contract for electricity supply, giving residents and businesses more choice and control over how we power our community while offering the potential for savings and increasing the amount of clean, renewable energy in our electricity supply.

Last year, Beverly joined more than 200 other Massachusetts communities that have this type of electricity program (called an "aggregation"), including our neighbors in Salem, Hamilton, and Gloucester. While the program cannot guarantee savings, historically residents and businesses have saved money compared to National Grid's Basic Service prices, and that has been true for Beverly rate payers.

With our second contract, Beverly Community Electric's Standard offering will include 100% renewable energy for less than National Grid's current Basic Service prices, and significantly reduce carbon emissions caused by our community's electricity use. This mailing offers information about your three new electricity options. As required by state law, this program will automatically enroll all current Beverly Community Electric customers in the new program offerings.

Beverly's second aggregation contract will run for 22 months starting January, 2026. While National Grid's Basic Service price is set twice a year and thus fluctuates, it is our goal that Beverly's fixed price program will both save you money over the life of the contract and ensure that more clean, renewable energy powers our homes and businesses.

Estimado miembro de la comunidad de Beverly:

Me complace anunciar que el programa Beverly Community Electric ha obtenido un segundo contrato de suministro eléctrico, lo que brinda a los residentes y negocios mayor libertad de elección y control sobre cómo abastecemos de energía a nuestra comunidad, además de ofrecer la posibilidad de ahorrar y aumentar la cantidad de energía limpia y renovable en nuestro suministro eléctrico.

El año pasado, Beverly se unió a más de 200 comunidades de Massachusetts que cuentan con este tipo de programa eléctrico (denominado "agregación"), incluyendo a nuestros vecinos de Salem, Hamilton y Gloucester. Si bien el programa no puede garantizar ahorros, históricamente los residentes y negocios han ahorrado dinero en comparación con los precios del Servicio Básico de National Grid, y esto también se ha cumplido para los usuarios de Beverly.

Con nuestro segundo contrato, la oferta Estándar de Beverly Community Electric incluirá energía 100% renovable a un precio menor que el actual Servicio Básico de National Grid, y reducirá significativamente las emisiones de carbono causadas por el consumo eléctrico de nuestra comunidad. Este correo electrónico ofrece información sobre sus tres nuevas opciones de suministro eléctrico. De acuerdo con la ley estatal, este programa inscribirá automáticamente a todos los clientes actuales de Beverly Community Electric en las nuevas ofertas del programa.

El segundo contrato de agregación de Beverly tendrá una duración de 22 meses a partir de enero de 2026. Si bien el precio del Servicio Básico de National Grid se fija dos veces al año y, por lo tanto, fluctúa, nuestro objetivo es que el programa de precio fijo de Beverly le permita ahorrar dinero durante la vigencia del contrato y garantice que más energía limpia y renovable alimente nuestros hogares y negocios.

A message from the City of Beverly about 2026 and 2027 electricity supply prices

Your electricity account is enrolled in **Beverly Community Electric**, our City's group electricity buying program. Under state law, enrollment occurs automatically for most electricity customers.

Through the program, you receive a Beverly price for the supply services portion of your National Grid electric bill. You are enrolled in the **Beverly Standard** option, which means you also receive an additional 10% of your electricity from renewable sources above the minimum required by state law.

In January, the program's current prices will expire, and new, near-level prices will take effect under a new, 22-month contract with First Point Power.

- Your electricity supply price will change from 13.919 ¢/kWh to **14.012 ¢/kWh**, a change of less than one-tenth of a cent. Your new price will be in effect until **November 2027**.
- Your new price is **lower** than all of National Grid's current Basic Service prices. See the other side for National Grid's prices.
Because National Grid's prices change and their future prices are unknown, future savings cannot be guaranteed.
- You will now receive **100% renewable electricity** from sources both within and outside of New England, and your program option name will change to **Beverly Standard Green**.

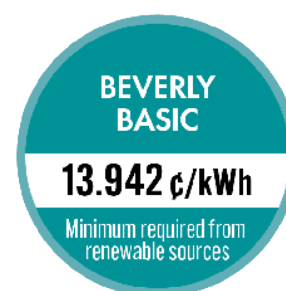
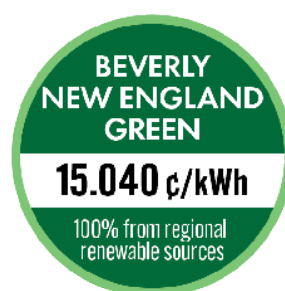

- ▶ **TAKE NO ACTION:** Your enrollment will automatically renew in the Beverly Standard Green option in January 2026 at 14.012 ¢/kWh. You will see the new price on your February 2026 National Grid electric bill.
- ▶ **CHOOSE A DIFFERENT PROGRAM OPTION:** Choose Beverly New England Green to receive 100% renewable electricity from sources that are all within the New England region. Choose Beverly Basic for the lowest price in the program.

- ▶ **LEAVE THE PROGRAM:** Participation is not required. There is no fee or penalty to opt out of Beverly Community Electric, and you may do so at any time. If you opt out, you will be returned to National Grid's Basic Service price.

Additional information:

- Beverly Community Electric has saved Beverly residents and businesses more than \$2.3 million compared with National Grid's prices since the program's launch in 2024. However, because National Grid's prices change and future prices are not known, future savings cannot be guaranteed.
- The program has helped to reduce our community's carbon footprint by more than 12.7 million pounds of CO₂ because most participants buy more electricity from renewable sources than is required by law. This is equivalent to avoiding the emissions associated with driving more than 14.6 million miles in an average passenger vehicle.
- Your electricity supplier will remain First Point Power, which has a track record of providing excellent service to our community. On your bill, you will continue to see "Beverly Community Electric-First Point Power." As always, your primary relationship for electricity remains with National Grid, and you will continue to call them if your power goes out. In addition, National Grid will continue to send your electric bill, and this is the only electric bill you will receive as a participant in Beverly Community Electric.
- At the end of the new contract with First Point Power, the City intends to sign another long-term contract. The electricity supplier and renewable energy content may change, and the price may be higher or lower than the current price. You will continue in the same program option at the new price unless you inform the program otherwise. The City will provide advance notice of any such changes, and you will be free to opt out or change your option before the changes take effect.
