



## Town electricity program notification of automatic enrollment

January 16, 2026



### ► Your electricity account is eligible for automatic enrollment in Lincoln Green Energy Choice.

Lincoln Green Energy Choice is a group electricity buying program from the Town that provides a competitive, stable price for the *supply* portion of your Eversource electric bill while increasing the amount of electricity you receive from renewable sources. Under state law, the program uses an automatic enrollment model, like all of the more-than-200 similar programs throughout Massachusetts. Eversource continues to deliver your electricity, send your electric bill, and address power outages.

Your account will be automatically enrolled in the **Lincoln Standard Green option**, which means:

- **Your electricity supply price will change to 15.409 ¢/kWh.** This price will remain stable until **January 2028**.  
*Please see the other side for a comparison with Eversource's current Basic Service prices.*
- **You will receive 77% of your electricity from new renewable sources in the New England region in 2026, 83% in 2027, and 89% in 2028.**

Your electricity account number is shown on the enclosed reply card.

### ► It's your decision. Make the choice that's right for you.

**Take no action:** If you take no action, you will be automatically enrolled in the Lincoln Standard Green option.

**Choose a different option:** Choose the Lincoln 100% Green option to receive 100% of your electricity from new renewable sources in the New England region. Choose Lincoln Basic for the lowest price in the program.

**Opt out:** Participation is not required. There is no fee or penalty to opt out of Lincoln Green Energy Choice, and you may do so at any time. **To avoid automatic enrollment, submit your opt-out request by February 18, 2026.** Or you may try the program and opt out at any time in the future.

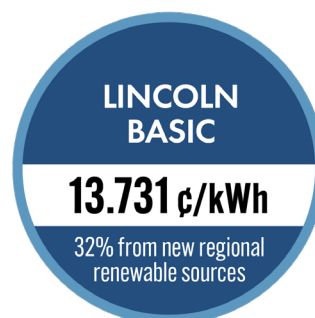

\* In addition to purchasing the renewable energy shown in the table, the program's electricity supplier is required by state law to purchase RECs from other clean or renewable sources. These other sources include waste-to-energy, nuclear, and large hydro projects, among others. This purchase must match 39% of participants' total electricity use.

## Additional information:

### Your electricity supplier will be First Point Power.

On your bill, you will see "Lincoln Green Energy Choice." But your primary relationship for electricity remains with Eversource, and you will continue to call them if your power goes out. In addition, Eversource will continue to send your electric bill, and this is the only electric bill you will receive as a participant in Lincoln Green Energy Choice.

**If you are eligible for a low-income discount or fuel assistance**, those benefits will continue in Lincoln Green Energy Choice.

**If you have solar panels on your property or you participate in a community solar program**, you will continue to receive your credits and/or incentive payments, and participating in Lincoln Green Energy Choice will not change their calculation.

**If you have a tax-exempt account**, you are responsible for requesting an exemption from the collection of any tax by providing tax-exemption documentation to First Point Power. Visit [LincolnGreenEnergyChoice.com](http://LincolnGreenEnergyChoice.com) to learn more.

**If you have received this notice and also you have signed a contract with an electricity supplier**, you may have signed

your contract after this mailing list was created. To continue receiving electricity from the supplier you chose and prevent any early termination fees from that supplier, you must opt out of LincolnGreenEnergyChoice.

**The automatic enrollment model is in accordance with state law.** More than 200 cities and towns in Massachusetts have similar programs, and all operate the same way. However, you are not required to participate. You may opt out at any time with no fee or penalty.

**At the end of the contract with First Point Power, the Town intends to sign a new long-term contract.** The electricity supplier and renewable energy content may change, and the price may be higher or lower than the current price. You will continue in the same program option at the new price unless you inform the program otherwise. The Town will provide advance notice of any such changes, and you will be free to opt out or change your option before the changes take effect.

If no action is taken, you will be automatically enrolled in Lincoln Green Energy Choice.

If you DO NOT wish to participate, you MUST opt out.

To opt out by mail:

1. Sign and date this card.
2. Place the card in the enclosed envelope.
3. Place the envelope in the mail.

This card must be signed by the Customer of Record whose name appears on this card. You may also opt out online at **LincolnGreenEnergyChoice.com** or by phone at **844-651-8919**.

Your opt-out request must be made by, or the envelope must be postmarked by, **February 18, 2026**, to opt out of the program before being automatically enrolled. If you choose to participate, you may opt out at any time in the future with no fee or penalty.
