



## City electricity program notification of automatic enrollment

January 30, 2026



Your electricity account is eligible for automatic enrollment in the **Green Worcester ElectriCITY Municipal Aggregation Program**, our city's group electricity buying program. Your electricity account number can be found on the enclosed reply card.

Participating in the program means:

- The electricity supply price on your National Grid electric bill will change to **15.320 ¢/kWh**. This price is **lower** than National Grid's current residential Basic Service price. Compare with all of National Grid's current prices on the other side.  
*Because National Grid's prices change and their future prices are unknown, future savings compared with National Grid cannot be guaranteed.*
- Your new price will be stable and will not change until **December 2027**.
- The amount of electricity you receive from new renewable sources will increase from 30% to 67%.
- You will remain a National Grid customer, and National Grid will continue to deliver your electricity and send your electric bill. If you are eligible for a low-income discount or fuel assistance, you will continue to receive those benefits **with no change**.

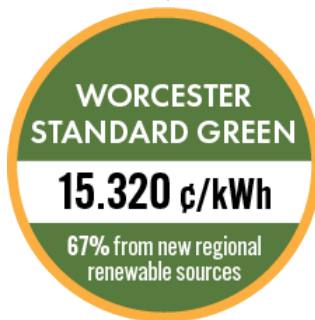

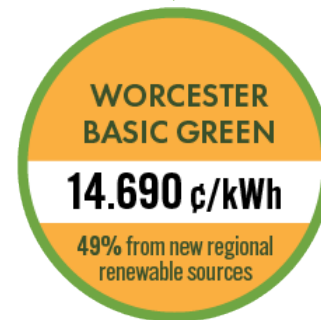

\* State law requires all electricity suppliers to purchase Renewable Energy Certificates (RECs) from other sources, including sources that are not new, are renewable but not clean, such as waste to energy, or are clean but not renewable, such as nuclear. This purchase must be made even if the total amount of RECs purchased from either clean or renewable sources exceeds 100% of the electricity used by Green Worcester ElectricCity Municipal Aggregation Program participants.

## Additional information:

**Your electricity supplier will change to Direct Energy Services, LLC ("Direct Energy").** On your bill, you will see "Green Worc ElectricCity Aggregation Prog." But your primary relationship for electricity remains with National Grid, and you will continue to call them if your power goes out. In addition, National Grid will continue to send your electric bill, and this is the only electric bill you will receive as a participant in the Green Worcester ElectricCity Municipal Aggregation Program.

**If you have solar panels on your property or you participate in a community solar program,** you will continue to receive solar credits and/or solar incentive payments, and participating in the Green Worcester ElectricCity Municipal Aggregation Program will not change how they are calculated.

**If you have a tax-exempt account,** you are responsible for requesting an exemption from the collection of any tax by providing appropriate tax-exemption documentation to Direct Energy. Visit [GreenWorcesterElectricCity.com](http://GreenWorcesterElectricCity.com) to learn more.

**If you have received this notice and also you have signed a contract with an electricity supplier,** you may have signed your contract after this mailing list was created. To continue receiving electricity from the supplier you chose and prevent any early termination fees from that supplier, **you must opt out of the Green Worcester ElectricCity Municipal Aggregation Program.**

**The automatic enrollment model is in accordance with state law.** More than 200 cities and towns in Massachusetts have similar programs, and all operate the same way. However, you are not required to participate. You may opt out at any time with no fee or penalty.

**At the end of the contract with Direct Energy,** the City intends to sign a new long-term contract. The electricity supplier and renewable energy content may change, and the price may be higher or lower than the current price. You will continue in the same program option at the new price unless you inform the program otherwise. The City will provide advance notice of any such changes, and you will be free to opt out or change your option before the changes take effect.

## Opt-Out Instructions

If no action is taken, your account will be automatically enrolled in the Green Worcester ElectriCITY Municipal Aggregation Program.

If you DO NOT wish to participate, you MUST opt out.

To opt out by mail:

1. Sign and date this card.
2. Place the card in the enclosed envelope and mail it.

This card must be signed by the Customer of Record whose name appears in the address on this card. You may also opt out online at **GreenWorcesterElectriCITY.com** or by phone at **833-926-1207**.

Your opt-out request must be made by, or the envelope must be postmarked by, **March 4, 2026**, to opt out of the program before being automatically enrolled. If you choose to participate, you may opt out at any time in the future with no fee or penalty.
