



## An important message from the Town of Canton about a change in your electricity supply price

May 8, 2026



Dear Canton Electricity Customer,

**You are receiving this notice because your electricity supply price will change in June.**

Your electricity account is enrolled in Canton Electricity Choice, our Town's group electricity buying program. The program aims to provide a competitive, stable price for the Supply portion of your Eversource electric bill. Under state law, enrollment occurs automatically for most electricity customers, and more than 200 other Massachusetts communities have similar programs.

From the program's 2024 launch to June 2026, Canton electricity customers will have saved an estimated **\$2.5 million** compared with Eversource's prices.

In June 2026, current program prices will expire and a new program price will take effect. The current prices were secured in 2024, and electricity prices have increased since then. As a result, your new Canton Electricity Choice price will be higher than your current price. However, your price will remain **lower** than Eversource's current residential and small business prices, and it will be **stable for 30 months**. *Eversource's prices are fixed through July 31, 2026, and savings beyond that date cannot be guaranteed.*

Canton Electricity Choice currently offers three options. Your account has been enrolled in the **Canton Basic** option, which provides the lowest price in the program. Under the new contract, the program will offer just one option, which includes only the minimum from renewable sources required by state law. *Please see the other side for an explanation of this change.* ▶

**It's your decision. Make the choice that's right for you.**

- ▶ If you want to continue participating: **No action is required.** Your enrollment in Canton Electricity Choice will renew automatically at 14.770 ¢/kWh in June, and you will see the new price on your **July Eversource electric bill**. Your electricity supplier will change from Constellation to First Point Power, and on your bill you will see "First Point-Canton Electricity Ch."
- ▶ If you want to leave the program: You are free to opt out with no fee or penalty. If you opt out, you will receive Eversource's current electricity supply price.

## New program structure explanation:

- ▶ **In the past:** Canton Electricity Choice previously supported renewable energy by purchasing more electricity from renewable sources than is required by Massachusetts state law for two program options, Canton Standard Green and Canton Plus Green. The goal of purchasing the extra renewable energy was to build demand for more renewable energy and drive the development of new renewable energy projects to meet it.
- ▶ **Now:** The federal government has substantially slowed the addition of new renewable energy projects by sunsetting tax credits, ending funding programs, slowing new permits, and seeking to revoke existing permits. It has become very difficult to build new renewable energy projects. As a result, for now, buying more renewable energy than is required by law will not result in the development of new renewable energy projects.
- ▶ **The new Canton Electricity Choice structure:** For that reason, beginning in June, Canton Electricity Choice will no longer purchase additional electricity from renewable sources. Accordingly, the program structure will change from three options to a single option, which includes only the minimum from renewable sources that is required by state law. To put it simply, Canton Electricity Choice no longer includes the purchase of additional electricity from renewable sources above the state requirement because, at this time, the extra cost associated with buying additional electricity from renewable sources does not facilitate the development of new renewable energy projects.

**The Town of Canton remains committed to supporting renewable energy. We anticipate adding renewable energy back into Canton Electricity Choice in the future, as the renewable energy landscape continues to evolve.**

- **If your account is tax exempt**, you must submit your tax-exemption documentation to First Point Power.
