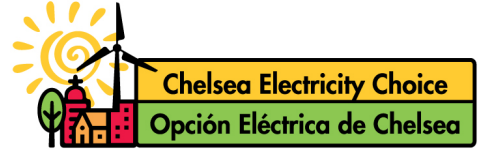




# An important message from the City of Chelsea about a change in your electricity supply price

May 19, 2026



## Your electricity supply price will change in June.

Your electricity account is enrolled in Chelsea Electricity Choice, our city's group electricity buying program. Through the program, you receive a Chelsea Electricity Choice price for the Supply portion of your electric bill. Under state law, enrollment in Chelsea Electricity Choice occurs automatically for most electricity customers.

You are enrolled in the **Chelsea Basic** option, which provides the lowest price available through the program. In June, your price will change as current program prices expire and new prices take effect.

- ▶ Your price will change from 12.42 ¢/kWh to 14.860 ¢/kWh. Electricity prices have increased since the current prices were secured in 2024, so your new price will be higher than your current price.
- ▶ Eversource's prices have also increased, and your new price will be **lower** than Eversource's current residential price (15.629 ¢/kWh) and small business price (15.030 ¢/kWh). *Eversource's prices are fixed through July 31, 2026, and savings beyond that date cannot be guaranteed.*
- ▶ Your new price will be stable for 30 months from **June 2026 - December 2028.**
- ▶ Your electricity supplier will change to First Point Power, and you will see "Chelsea Electricity Ch-First Point" on your bill. Eversource will continue to deliver your electricity, send your bill, and address power outages.

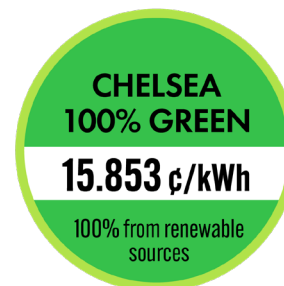
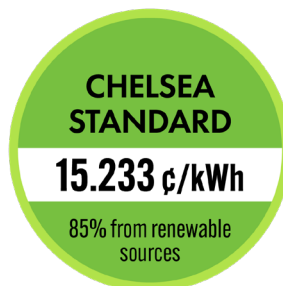
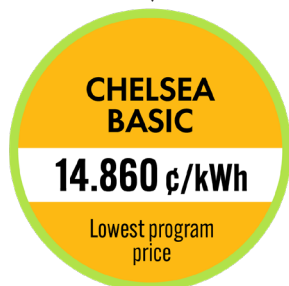
## It's your decision. Make the choice that's right for you.

If you want to continue participating in Chelsea Electricity Choice: **No action is required.** Your enrollment in the Chelsea Basic option will renew automatically at 14.860 ¢/kWh in June, and you will see the new price on your July Eversource electric bill.

If you want to participate in a different option: The Chelsea Standard and Chelsea 100% Green options are available by request.

If you want to leave Chelsea Electricity Choice: You are free to opt out with no fee or penalty and receive Eversource's current electricity supply price or sign your own contract with an electricity supplier. See Eversource's current prices on the other side. ▶

Additional information:

- **Chelsea Electricity Choice has saved participants more than \$2.7 million** compared with Eversource’s prices since the program’s launch in June 2024. However, because Eversource’s prices change and future prices are not known, future savings cannot be guaranteed.
- **If you recently signed a private electricity supply contract and also you received this notice**, this mailing list may have been created before you signed your contract. If you wish to remain in your contract, **you should opt out of Chelsea Electricity Choice.**
- **If your account is tax exempt**, you must submit your tax-exemption documentation to First Point Power. Tax-exemption documentation must be submitted each time the program’s electricity supplier changes. - **At the end of the new contract with First Point Power**, the City intends to sign another long-term contract. The electricity supplier and renewable energy content may change, and the price may be higher or lower than the current price. You will continue in the same program option at the new price unless you inform the program otherwise. The City will provide advance notice of any such changes, and you will be free to opt out or change your option before the changes take effect.
