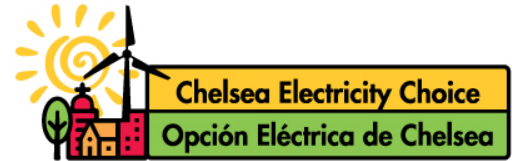




City electricity program notification of automatic enrollment

July 30, 2026



Your electricity account is eligible for **AUTOMATIC ENROLLMENT** in the City's electricity program, **Chelsea Electricity Choice**. The program is a City alternative to other electricity offers, but without high pressure or fees.

If you participate in Chelsea Electricity Choice, Eversource will continue to deliver your electricity, send your electric bill, and address power outages, but you will have a new price for the supply portion of your bill.

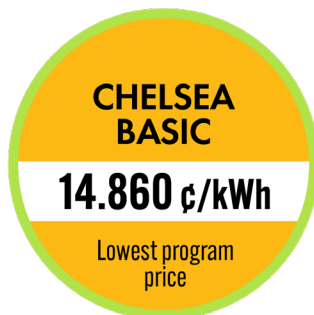
- The electricity supply price on your Eversource electric bill will change to **14.860 ¢/kWh**.
- Your new price will be **lower** than Eversource's current residential and small business electricity supply prices, which are listed on the other side.

Eversource's prices change and future prices are unknown, so future savings compared with Eversource cannot be guaranteed.

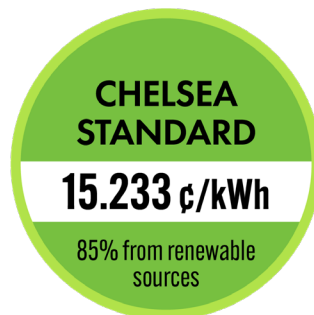
- Your new price will be fixed and stable until **December 2028**.

It's your decision. Make the choice that's right for you.

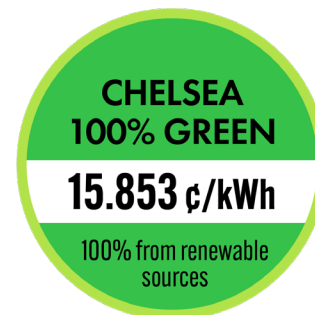
- ▶ **If you want to participate: Take no action.** You will be automatically enrolled in the Chelsea Basic option at 14.860 ¢/kWh, which provides the lowest price available through the program.
- ▶ **If you want to buy more of your electricity from renewable sources:** Choose the Chelsea Standard option to receive 85% of your electricity from renewable sources, or choose the Chelsea 100% Green option to receive 100% of your electricity from renewable sources.

Chelsea Electricity Choice prices are fixed until **December 2028**. See the other side to compare with Eversource's prices.

- ▶ **If you do not wish to participate:** Participation is not required, and you may opt out. There is no fee or penalty to opt out of Chelsea Electricity Choice, and you may do so at any time. If you do not participate, you will remain with Eversource's current electricity supply price.

To avoid being automatically enrolled, you must do one of the following before September 1, 2026: Sign and mail the enclosed reply card, opt out online at ChelseaElectricityChoice.com, or call 3-1-1 (617-466-4209 from outside Chelsea) or 833-393-5675. You may also try the program and opt out at any time in the future with no fee or penalty.

Additional information:

Your electricity supplier will change to First Point Power.

On your bill, you will see "Chelsea Electricity Ch-First Point." But your primary relationship for electricity remains with Eversource, and you will continue to call them if your power goes out. In addition, Eversource will continue to send your electric bill, and this is the only electric bill you will receive as a participant in Chelsea Electricity Choice.

If you are eligible for a low-income discount or fuel assistance, those benefits will continue in Chelsea Electricity Choice.

If you have solar panels on your property or you participate in a community solar program, you will continue to receive solar credits and/or solar incentive payments, and participating in Chelsea Electricity Choice will not change how they are calculated.

If you have a tax-exempt account, you are responsible for requesting an exemption from the collection of any tax by providing appropriate tax-exemption documentation to First Point Power. Visit ChelseaElectricityChoice.com to learn more.

If you have received this notice and also you have signed a contract with an electricity supplier, you may have signed your contract after this mailing list was created. To continue receiving electricity from the supplier you chose and prevent any early termination fees from that supplier, **you must opt out of Chelsea Electricity Choice.**

The automatic enrollment model is in accordance with state law. More than 200 cities and towns in Massachusetts have similar programs, and all operate the same way. However, you are not required to participate. You may opt out at any time with no fee or penalty.

At the end of the contract with First Point Power, the City intends to sign a new long-term contract. The electricity supplier and renewable energy content may change, and the price may be higher or lower than the current price. You will continue in the same program option at the new price unless you inform the program otherwise. The City will provide advance notice of any such changes, and you will be free to opt out or change your option before the changes take effect.

You do not need to take any action to participate in Chelsea Electricity Choice.

If you DO NOT wish to participate, you MUST opt out.

To opt out by mail:

1. Sign and date this card.
2. Place the card in the enclosed envelope.
3. Drop the envelope in the mail.

This card must be signed by the Customer of Record whose name appears in the address on this card. The envelope must be postmarked by **September 1, 2026**, to opt out of the program before being enrolled. You may also opt out online at ChelseaElectricityChoice.com or by phone at **833-393-5675** before being enrolled or anytime after enrollment.
